BILL TO DESIGNATE AUTHORIZED ORGANIZATIONAL REPRESENTATIVE FOR THE ANA SEDS GRANT

Frank Adams to be its Authorized Organization Representative (AOR), for ANA SEDS Grant Tribal Project entitled Sovereign Promise: Realizing the Upper Mattaponi Future.
