**ANNUAL BUDGET FOR FISCAL YEAR 2023-2024**

At a duly called Regular Meeting of the Council held this 28th day of September, 2023, the following Resolution and Law were adopted.

**WHEREAS;** the Council is vested with the authority to enact laws and Budget Resolutions pursuant to Article VI, Section 4(a) of the Constitution of the Upper Mattaponi Tribe (“Constitution”); and,

**WHEARAS;** the Constitution calls for the Chief and Council to develop an Annual Budget for the Tribe comprised of all projected revenue and an appropriation of funds for all branches of government; and,

**WHEREAS;** the Chief and Council have developed an Annual Budget for the Tribe, primarily based on the prior year’s budget, to fund the operations of the Tribe’s government in accordance with the new Constitution.

**NOW THEREFORE IT BE IT RESOLVED** that the Council hereby approves the attached ANNUAL BUDGET FOR FISCAL YEAR 2023-2024.

**Section 101. Short Title.**

This enactment shall be known as the Budget Resolution to approve the Annual Budget for Fiscal Year 2023-2024 (“Resolution”).

**Section 102. Purpose.**

The purpose of the Resolution is to approval the Annual Budget for Fiscal Year 2023-2024.

**Section 103. Findings.**

The Council hereby finds and declares that:

- (a) The Council is vested with the authority to enact laws and Budget Resolutions pursuant to Article VI, Section 4(a) of the Constitution of the Upper Mattaponi Tribe (“Constitution”); and,
- (b) the Constitution calls for the Chief and Council to develop an Annual Budget for the Tribe comprised of all projected revenue and an appropriation of funds for all branches of government; and,
- (c) the Chief and Council have developed an Annual Budget for the Tribe, primarily based on the prior year’s budget, to fund the operations of the Tribe’s government in accordance with the new Constitution.
