

UPPER MATTAPONI TRIBE RESOLUTION NO. 2024-12

LONG-RANGE TRANSPORTATION PLAN AND INVENTORY UPDATE

At a duly called Regular Meeting of the Council held this 22 day of June, 2024, the following Resolution and Law were adopted.

- WHEREAS, the Long-Range Transportation Plan Inventory update project Phase I and II (PROJECT) IS PRIORITY TO THE Tribe, and;
- WHEREAS, the Long-Range Transportation Plan and Inventory update project Phase I and II (PROJECT) is multiple phases due to the complexes of the Tribal Transportation planning services area for the Tribe, and;
- WHEREAS, the PROJECT is identified to be on the Tribal Transportation Improvement Program (TIP), as governed by federal law and regulations, 25 CFR Tribal Transportation Program, and;
- WHEREAS, the Tribe may request planning services to be performed for PROJECT by Bureau of Indian Affairs (BIA), Eastern Region, Division of Transportation for the development of a long-range transportation plan and inventory update for the Tribe and;
- **WHEREAS**, the Tribe has estimated \$30,000 from the Tribes' Tribal Share funding to be used by the BIA to perform services for the PROJECT for the Tribe.
- **NOW, THEREFORE, BE IT RESOLVED** that the Tribe approves the PROJECT to be identified on the Tribal Transportation Improvement Program (TIP), AND
- **NOW, THEREFORE, BE IT FURTHER RESOLVED** that the Tribe approves the Long-Range Transportation Plan and Inventory update project Phase I and II (PROJECT) as a priority to the Tribe, and;

NOW, THERFORE, BE IT FURTHER RESOLVED that the Tribe is requesting services to be performed for PROJECT by Bureau of Indian Affairs (BIA), Eastern Region, Division of

Transportation for the development of a Long-Range Transportation Plan and Inventory update project (PROJECT) for the Tribe and;

FINALLY, BE IT FURTHER RESOLVED that the Tribe approves \$30, 000 from the Tribes' Tribal Share funding to be used for BIA planning services.
