

## UPPER MATTAPONI TRIBE RESOLUTION NO. 2024-15

## THE APPOINTMENT OF LAURIE K.C. GILLIAM TO THE BOARD OF DIRECTORS OF UMIT SERVICES, LLC

A Resolution appointing Laurie K.C. Gilliam to the Board of Directors of UMIT Services, LLC, following the resignation of Steven M. Tupponce, to ensure continued leadership of the tribally owned company.

At a duly called Regular Meeting of the Upper Mattaponi Tribe Council held this 28 day of September, 2024, the following Resolution and Law were adopted.

- **WHEREAS**, the Upper Mattaponi Tribe (the "Tribe") is a recognized sovereign American Indian tribal nation headquartered in King William, Virginia; and
- WHEREAS, the Tribe formed UMIT Services, LLC as a Tribally Owned Limited Liability Company pursuant to the Upper Mattaponi Indian Tribe Limited Liability Company Code; and
- WHEREAS, Section 10 of the Operating Agreement for UMIT Services, LLC, Tribal Council delegated the management of the Company and all business affairs to a set of Board of Directors; and
- WHEREAS, Steven M. Tupponce has resigned his position as a Board of Director of UMIT Services, LLC effective October 01, 2024; and
- WHEREAS, Article XVI of the Tribe's Constitution grants Chief William F. Adams the authority to nominate Board members which are subject to confirmation by the Council; and
- **BE IT RESOLVED** that Chief William F. Adams hereby nominates Laurie K.C. Gilliam to fill the unexpired term of Steven M. Tupponce; and

**NOW THEREFORE BE IT RESOLVED** that Chief William F. Adams requests Council to confirm Laurie K.C. Gilliam to the Board of Directors for UMIT Services, LLC; and

**BE IT FURTHER RESOLVED** that Council confirms Laurie K.C. Gilliam to the Board of Directors for UMIT Services. LLC.
