

UPPER MATTAPONI TRIBE RESOLUTION NO. 2025-13

AUTHORIZATION TO TRANSITION ATG CONTRACT TO CTGP

A Resolution to authorize transitioning the Tribe's "Aid to Tribal Government" (ATG) Contract to a "Consolidated Tribal Government Program" (CTGP)

At a duly called General Meeting of the Upper Mattaponi Tribal Council held this 27th day of September, 2025, the following Resolution and Law were adopted.

- WHEREAS, the Upper Mattaponi Tribe (the "Tribe") is an Indian Tribe that has existed from time immemorial and is federally recognized on a government-to-government basis by the United States of America; and
- WHEREAS, Pursuant to Article VII, Section 4(c) of the Constitution of the Upper Mattaponi Tribe, the Upper Mattaponi Tribal Council (the "Council") is vested with the authority to enact laws for the safety, health, and welfare of the Upper Mattaponi Tribe (the "Tribe"); and
- WHEREAS, the Tribe is eligible for program funds from the Untied States of America pursuant to Public Law 93-638, commonly referred to as "638 Contracts;" and
- WHEREAS, the Legislature previously adopted the Self-Determination 638-Contracts Authorization Act of 2023, which authorized the Chief of the Tribe to negotiate and execute 638 Contracts on behalf of the Tribe. See Title 1, Chapter 2 of the Upper Mattaponi Tribal Code of Laws; and
- WHEREAS, currently the Tribe receives approximately \$175,000 annually in funding under an Aid to Tribal Government ("ATG") 638 Contract; and
- WHEREAS, transferring the annual funding from an ATG Contract to be included in a Consolidated Tribal Government Program ("CTGP") would reduce administrative burdens, streamline reporting, and provide greater flexibility.

NOW THEREFORE BE IT RESOLVED THAT the Upper Mattaponi Tribal Council hereby indicates its support in switching its annual funding from an ATG Contract to a CTGP model.

BE IT FURTHER RESOLVED THAT the Upper Mattaponi Tribe requests that the change from an ATG Contract to the CTGP model be made as a modification to the current ATG Contract rather than in the form of a new contract,

BE IT FURTHER RESOLVED THAT the Upper Mattaponi Tribe requests that it operate its CTGP funding on a fiscal award year basis (October 1 to September 30) instead of on a calendar year basis.
